

PUBLIC INTEREST DISCLOSURE (PID) OFFICERS – As at 12 December 2023

ACT Public Service and Legislative Assembly entities are required to nominate people who may receive reports of wrongdoing. Where reports of wrongdoing meet certain criteria, they may be designated PIDs. People who make PIDs are protected against retaliatory action being taken against them in response to making a report. The following table lists disclosure officers in the ACT. Reports of wrongdoing can be made to any disclosure officer within the ACT.
